
## RESOLUTION 2016:167 A RESOLUTION PROVIDING FOR A MEETING NOT OPEN TO THE PUBLIC IN ACCORDANCE WITH THE PROVISIONS OF THE NEW JERSEY OPEN PUBLIC MEETINGS ACT, NJSA 10:4-12

WHEREAS, the Governing Body of the Borough of Stratford is subject to certain requirements of the *Open Public Meetings Act*, NJSA 10:4-6 et seq., and

WHEREAS, the *Open Public Meetings Act, NJSA 10:4-12*, provides that an Executive Session, not open to the public, may be held for certain specified purposes when authorized by Resolution, and

WHEREAS, it is necessary for the Governing Body of the Borough of Stratford to discuss in a session not open to the public certain matters relating to the item or items authorized by NJSA 10:4-12b and designated below:

- \_\_\_\_\_(1) *Matters required by Law to be Confidential*: Any matter which, by express provision of Federal law or State statute or rule of court shall be rendered confidential or excluded from the provisions of the Open Public Meetings Act.
- \_\_\_\_\_(2) Matters Where the Release of Information Would Impair the Right to Receive Funds: Any matter in which the release of information would impair a right to receive funds from the Government of the United States.
- \_\_\_\_\_\_(3) Matters Involving Individual Privacy: Any material the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including, but not limited to information relative to the individual's personal and family circumstances, and



(9) Matters Relating to the Potential Imposition of a Penalty: Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party bears responsibility.

NOW, THEREFORE BE IT RESOLVED by the Governing Body of the Borough of Stratford, assembled in public session on December 08, 2016 that an Executive Session closed to the public shall be held on December 08, 2016 at approximately 7:00 p.m. in the Justice Facility, 315 Union Avenue, Stratford, NJ for the discussion of matters relating to the specified items designated above. It is anticipated that the deliberations conducted in Closed Session may be disclosed to the public upon the determination of the Governing Body that public interest will no longer be served by such confidentiality.

The following resolution was duly adopted by the Governing Body of the Borough of Stratford at a public meeting held on December 08, 2016 by a motion of Councilman Angeli, seconded by Councilman Gray and all Council voting aye.

COMMENTS:

Councilman Angeli invited friends and family to the Tuesday Council Meeting to honor the Stratford Police Department.

Councilman Gray thanked all who helped with the Miss Stratford Pageant which had 7 contestants and was a fun night overall. He added the tree lighting was successful with over 90 baskets given away.

Councilman Angeli stated Mike Maloney should be at the next Council Meeting to give an update on the status of the SBCA.

Councilman Green thanked all who helped with the tree lighting. He stated it was more crowded than usual and thanked the fire company for use of their hall.

The Mayor commented there were over 100 children present and the local school choir sang.

## GOOD WELFARE:

Agnes Moore of Laureba Avenue inquired if Brandywine had settled yet. Councilwoman Tate responded they have not. She explained there was a NJDEP file not completed for an old DEP issue and some title issues. Brandywine is still going to buy the site. Councilwoman Tate explained some of the conditions of the memo of understanding.

John Gentless of Union Avenue inquired if there was a wetland study done for the property on Berlin Road. The Clerk stated no.

Harry Berry of Cornell Avenue inquired about sidewalks on the corner of Cornell Avenue and White Horse Pike. He also noted he was upset with NJ spending money to renovate the capital building.

Agnes Moore thanked Councilman Angeli and Councilwoman Tate for their service to the town.

At this time the Solicitor noted John Gentless, Shade Tree Member was provided a Rice Notice and Mr. Gentless responded he wanted any discussion to be done in open session versus closed session. The Solicitor noted there were trees replaced without Council's authorization. Mr. Gentless gave the history of the accident which took out 4 borough curbside trees and he noted emails between the Borough Clerk and himself. The Clerk then explained the emails and how the email noted everything was to go through the Clerk's Office, which was also confirmed in the email by the Solicitor. Councilman Angeli inquired about how Mr. Gentless had been told not to spend money prior. Councilwoman Tate detailed two separate occasions where Mr. Gentless was told not to make any decisions and with this one being the third time. Councilman Angeli spoke about removing the shade tree member. The Solicitor noted the process for removing the member which would include a public hearing, witnesses, etc. The Solicitor again noted Mr. Gentless wanted this discussion in public and he also confirmed he was told previously not to spend money and was being told again in public not to spend any money in the future. Jake Gambon, shade tree member spoke about the commission having the authority to spend without Council. Councilman Angeli spoke about the listing of dangerous trees which this insurance money could have been spent on rather than plant 6 additional trees in an area which already has too many trees.

Councilman Angeli made a motion to adjourn with Councilman Gray making the second and all of Council voting aye.
