LIGHTING:

There were eleven (11) call outs for emergency service, performed preemptive checks of all manholes and pump station; sewer line maintenance performed n/a; work requests performed, removed snow from Borough building and property sidewalks, changed light bulbs at the library; regular maintenance activities performed include, weekly trash pickup and clean up at Yellin, Parkveiw schools and Vassar Avenue ball fields, clearing of storm drains of debris after the rain, bi-weekly town wide metal/appliance collection. He also reported the FEMA reimbursement for the wind storm of June 2015 was received. He stated the FEMA application was being made for the January 2016 snow storm. He reported on the public events in the absence of Councilman Gray. He stated the Easter Egg Hunt is scheduled for March 26.

ORDINANCE

Councilwoman Tate stated the Bradlees Committee met in February with the owner & PROPERTY: related to the litigation about affordable housing which is an ongoing negotiation. The Committee met again to re-strategize that side and to comply with the Judge's order to mediate in good faith. The Incollingo's Committee met to reconsider the plan submitted by Mr. Sethi. The Committee had met previously in November 2015 but the litigation for affordable housing held up moving forward. The Committee met this week and a letter requesting certain items will be sent to Mr. Sethi. This is an ongoing process but there is movement on both sides with variable options for the near future. She stated the Committee has narrowed the attorneys who replied to the Redevelopment Solicitor RFP to four attorneys to be interviewed. She reported the code officers made 26 inspections, with 14 warning letters and 1 code summons issued. She also reported there were 10 resolutions and 1 ordinance to act on this evening.

ORDINANCE 2016:04

AN ORDINANCE PROVIDING FOR VACANT/ABANDONDED PROPERTIES

WHEREAS, the Borough of Stratford ("Borough") contains structures which are vacant in whole or large part; and

WHEREAS, in many cases, the owners or responsible parties of these structures are neglectful of them, and not maintaining or securing them to an adequate standard, or restoring them to productive use; and

WHEREAS, it has been established that vacant and abandoned structures cause severe harm to the health, safety, and general welfare of the community, including diminution of neighboring property values, increased risk of fire and potential increases in criminal activity and public health risks; and

WHEREAS, the Borough incurs disproportionate costs in order to deal with the problems of vacant and abandoned structures, including but not limited to, excessive police calls, fire calls, and property inspections; and

WHEREAS, it is in the public interest for the Borough to establish minimum standards of accountability on the owners or other responsible parties of vacant and abandoned structures in order to protect the health, safety and general welfare of the residents of the Borough.

Section 1

This ordinance governs the maintenance of vacant property in the Borough of Stratford amending registration requirements and amending registration fees for owners of vacant properties.

Section 2 – Definitions.

"Owner" shall include the title holder, any agent of the title holder having authority to act with respect to a vacant property, and foreclosing entity subject to the provision of C.46:10B-51 (P.L. 2008, c. 127, Sect, 17) or any other entity determined by the Borough of Stratford to have authority to act with respect to the property.

"Vacant Property" shall mean any building used or to be used which is not legally occupied or at which substantially all lawful construction operations or occupancy has ceased, provided, however, that any property that contains all building systems in working order, is fully compliant with our property maintenance codes and is being actively marketed by its owner for sale or rental, shall not be deemed vacant. Property determined to be "abandoned property" in accordance with the meaning of such term in the Abandoned Properties Rehabilitation Act, N.J.S.A. 55:19-78, et seq. shall also be deemed to be vacant property for the purposes of this ordinance.

Section 3

- A. Effective July 1, 2016, the owner of any vacant property as defined herein shall within sixty (60) days after the building becomes vacant property or within thirty (30) days after assuming ownership of the vacant property, whichever is later, file a registration statement for each such vacant property with the Zoning Officer or his designee on forms provided by the Zoning Officer or his designee for such purposes. The registration shall remain valid for one (1) year from July 1 until June 30 of the following year. The owner shall be required to renew the registration annually as long as the building remains vacant property and shall pay a registration or renewal fee in the amount prescribed in this Chapter for each vacant property registered.
- B. Any owner of any building that meets the definition of vacant property prior to July 1, 2016, shall file a registration statement for that property on or before July 30, 2016. The registration statement shall include the information required under this Chapter, as well as any additional information that the Zoning Officer or his designee may reasonably require.
- C. The owner shall notify the Zoning Officer or his designee within thirty (30) days of any change in the registration information by filing an Amended registration statement on a form provided by the Zoning Officer or his designee for such propose.
- D. The registration statement shall be deemed prima facie proof of the statements therein contained in any administrative enforcement proceeding or court proceeding instituted by the Borough against the owner or owners of the building.

Section 4 – Registration statement requirements; Property Inspection

After filing a registration statement or a renewal of a registration statement, the Owner of any vacant property shall provide access to the Borough to conduct an exterior and interior inspection of the building to determine compliance with the municipal code, following reasonable notice, during the period covered by the initial registration or any subsequent renewal.

- A. The registration statement shall include the name, street address, email address and telephone number of a natural person 21 years of age or older, designated by the owner or owners as the authorized agent for receiving notice of code violations and for receiving process, in any court proceeding or administrative enforcement proceeding, on behalf of such owner or owners in connection with the enforcement of any applicable code. This person must maintain an office in the State of New Jersey or reside within the State of New Jersey. The statement shall also include the name, street address, email address and telephone number of the person responsible for maintaining and securing the property, if different.
- B. An owner who is a natural person and who meets the requirements of this ordinance as to location of residence or office may designate him or herself as agent.

C. By designating an authorized agent under the provisions of this section the owner consents to receive any and all notices of code violations concerning the registered vacant property and all process in any court proceeding or administrative enforcement proceeding process on the authorized agent. Any owner who has designated an authorized agent's designation for the purposes of this section until the owner notifies the Zoning Officer or his designee of a change of authorized agent or until the owner files a new annual registration statement. The designation of an authorized agent in no way releases the owner from any requirement of this ordinance.

Section 5 – Fee Schedule

The registration fee for each building shall be \$500.00 per year, \$1,000.00 for the second, and \$1,500.00 for the third year and each year thereafter.

Section 6 - Requirements of Owners of Vacant Property

The owner of any building that has become vacant property, and any person maintaining, operating or collecting rent for any such building that has become vacant shall within thirty (30) days:

- A. Enclose and secure the building against unauthorized entry as provided in the applicable provisions of the code of the Borough of Stratford.
- B. Post a sign affixed to the building indicating the name, address and telephone number of the owner, the owner's authorized agent for the purpose of service of process and the person responsibility for day-to-day supervision and management of the building, if such person is different from the owner holding title or authorized agent. The sign shall be of a size and placed in such a location so as to be legible from the nearest public street or sidewalk, whichever is nearer, but shall be no smaller than 18x24.
- C. Secure the building from unauthorized entry and maintain the sign until the building is again legally occupied or demolished or until repair or rehabilitation of the building is completed.
- D. Post the property with No Trespassing signs in a nature sufficient to give notice to any person entering upon the property that is against the law to enter the property without permission of the owner.

Section 7 - Administration

The Zoning Officer or his designee may issue rules and regulations for the administration of the provision of this ordinance.

Section 8 – Violations and penalties

- A. Any owner who is not in full compliance with this ordinance or who otherwise violates any provision of this ordinance or of the rules and regulations issued herein shall be subject to a fine of not less than \$500.00 and not more than \$1,000.00 for each offense. Fines assessed under this chapter shall be recoverable from the owner and shall be a lien on the property.
- B. For purposes of this section, failure to file a registration statement in time, failure to provide correct information on the registration statement, failure to comply with the provisions of this Chapter or such other matters as many be established by the rules and regulations of the Zoning Officer or his designee, shall be deemed to be violations of this ordinance.

Section 9

Nothing in this ordinance is intended nor shall be read to conflict or prevent the Borough from taking action against buildings found to be unfit for human habitation or unsafe structures as provided in applicable provisions of the Code of the Borough of Stratford. Further, any action taken under any such code provision other than the demolition of a structure shall relieve an owner from its obligation under this ordinance.

Section 10

This Ordinance shall take effect immediately.

Section 11

The provisions of this Ordinance are severable. To the extent any clause, phase, sentence, paragraph or provision of this Ordinance shall continue in full force and effect.

Section 12

Any funds collected as vacant property registration fees in excess of the funds necessary

to operate and enforce the provisions of this Chapter shall be set aside in a dedicated fund for the purpose of property rehabilitation within the Borough of Stratford at the discretion of the Governing Body.

BE IT FURTHER ORDAINED that if any section, subsection, paragraph, sentence or other party of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance, but shall be confined in its effect to the section, subsection, paragraph, sentence or other part of this Ordinance directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Ordinance shall remain in full force and effect.

BE IT FURTHER ORDAINED this Ordinance shall take effect immediately upon final adoption and publication in the manner prescribed by law.

WHEREAS, the Governing Body of the Borough of Stratford is subject to certain requirements of the *Open Public Meetings Act*, NJSA 10:4-6 et seq., and

WHEREAS, the *Open Public Meetings Act, NJSA 10:4-12*, provides that an Executive Session, not open to the public, may be held for certain specified purposes when authorized by Resolution, and

WHEREAS, it is necessary for the Governing Body of the Borough of Stratford to discuss in a session not open to the public certain matters relating to the item or items authorized by NJSA 10:4-12b and designated below:

(1) Matters required by Law to be Confidential: Any matter which, by														
express	provision	of	Federal	law	or	State	statute	or	rule	of	court	shall	be	rendered
confidential or excluded from the provisions of the Open Public Meetings Act.														

_____(2) Matters Where the Release of Information Would Impair the Right to Receive Funds: Any matter in which the release of information would impair a right to receive funds from the Government of the United States.

_____(3) *Matters Involving Individual Privacy*: Any material the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social

service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including, but not limited to information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly.

______(4) *Matters Relating to Collective Bargaining Agreements*: Any collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body.

______(5) Matters Relating to the Purchase, Lease or Acquisition of Real Property or the Investment of Public Funds: Any matter involving the purchase, lease, or acquisition of real property with public funds, the setting of banking rates or investment of public funds, where it could adversely affect the public interest if discussion of such matters were disclosed.

_____(6) *Matters Relating to Public Safety and Property*: Any tactics and techniques utilized in protecting the safety and property of the public, provided that their disclosure could impair such protection. Any investigations of violations of possible violations of the law.

Z_______(7) Matters Relating to Litigation, Negotiations and the Attorney-Client Privilege: Any pending or anticipated litigation or contract negotiation in which the public body is, or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer. The topic of discussion is related to Attorney/Client Privilege to discuss related to the Stratford Complaint for Declaratory Judgment Docket No. L2613-15 Civil Action, Relief Pursuant to the Fair Housing Act, NJSA 52:27D-313 and the Mt. Laurel Doctrine and to interview special redevelopment counsel. This item is for #7 of the Executive Session Resolution for matters relating to litigation, negotiations, and the Attorney-Client Privilege. The approximate time of this session should be 60 minutes. Action may be taken after this Executive Session.

______(8) *Matters Relating to the Employment Relationship*: Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting.

(9) Matters Relating to the Potential Imposition of a Penalty: Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party bears responsibility.

NOW, THEREFORE BE IT RESOLVED by the Governing Body of the Borough of Stratford, assembled in public session on March 8, 2016 that an Executive Session closed to the public shall be held on March 8, 2016 at approximately 7:00 p.m. in the Justice Facility, 315 Union Avenue, Stratford, NJ for the discussion of matters relating to the specified items designated above. It is anticipated that the deliberations conducted in Closed Session may be disclosed to the public upon the determination of the Governing Body that public interest will no longer be served by such confidentiality.
