John Gentless, 110 Union Avenue – Mr. Gentless asked if the Stratford Commons townhomes were connected to the sewer system. Mr. Bach stated there is no live sewer use at this time and his office is working on the pumping station upgrades that consists of new starting equipment for the pumps which will increase the capacity. Mr. Bach stated the upgrades are being paid for by the developer but are not required to be completed at this time.

<u>POLICE/OEM REPORT</u>: Administrator/Department Head Morello provided the following report of the Stratford Borough Police Department Activities for March 2023.

Mr. Morello stated the vent is a good fundraiser for the swim club and it won't return for another 9 years. Mr. Morello stated providing busing would cost too much. Mr. Morello stated the new firearms are now in service and officers are pleased and the weapons are more accurate and have improved firearms qualification scores.

ENGINEER REPORT:

Mr. Bach stated the written report was submitted to Council. Mr. Bach stated the cost of some building materials is falling and they hope it will result in lower bids on architectural projects. There were no questions or comments. Mr. Bach stated the Borough has applied for CDBG funding but should not expect an award because it received funding last year.
