PUBLIC PORTION FOR AGENDA ITEMS ONLY:

Councilman Gilligan motioned to open the public portion on agenda items only. Councilman Tolomeo seconded the motion, which passed with all members present voting in favor in a voice vote.

There were no comments.

Councilman Gandy motioned to close the public portion for agenda items. Councilman Kelly seconded the motion, which passed with all members present voting in favor in a voice vote.

Councilwoman Hall joined the meeting at 6:33 p.m.

POLICE/OEM REPORT: Administrator/Department Head Morello provided the following report of the Stratford Borough Police Department Activities for June 2023.

June 2 – Police responded to Yellin School for a dispute between a student's parents over their participation in a class trip. There was no resolution and the student unfortunately did not go to Great Adventure.

June 7 – An employee of Tomkinson's Auto reported the catalytic converter was stolen from one of their vehicles while they stopped by the shop in the evening to complete office work.

June 11 – An unknown suspect stole scrapped generators and engine parts from Joe's Small Engine Repair.

June 15 – A vehicle struck a large deer on Laurel Road, near Warwick Road just as school dismissed for the day. Police quickly euthanized the mortally wounded animal.

June 17 – Police responded to a neighbor dispute on Cooper Ave. Complaints were issued by police for disorderly conduct and harassment.

June 18 – Police received a report from a Jefferson Hospital patient that their car was stolen from the hospital parking lot. The vehicle has not yet been recovered.

June 22, 24 & 25 — Police responded to Jefferson Hospital for healthcare workers who were assaulted by patients. A Camden man and a Lawnside man were charged in separate cases. A 71-year-old Newark woman was not charged.

June 25 – Police & fire department responded to a Webster Ave home for a fire. The cause was determined to be careless smoking.

June 25 – The Borough was hit by a powerful storm that caused: flooding, loss of power, including two traffic lights and a two sewer pump stations, 7 vehicles towed from flooded roadways, fallen tree limbs and downed power lines. DPW respond that evening to clean streets of debris.

June 26 – Police responded to CVS for a homeless woman being disruptive and spitting on the manager. Police found the female suspect harassing people at Tim Hortons and she was charged and banned from both locations.

June 28 – Police responded to Vassar Ave for reports of a naked man walking near the playground. Police found the naked and intoxicated man at Hagerty Field. The 39-year-old was determined to be a new resident and he was charged with lewdness and disorderly conduct.

June 30 – Police responded to a home in the Wood & Leaves section for the report of a 33-year-old man who was found dead in the bathroom from a suspected drug overdose.

June 30 – Police responded to the Residences at Whitehall for the report of an unconscious 45-year-old man. Police determined the man had died of natural causes.

Mr. Morello stated the Borough will create a First Aid Division within OEM CERT Team via an Explorer program to give Borough youth an opportunity for community service. Mr. Morello stated the program hopefully will generate more interest among younger residents to serve on the ambulance squad or fire department.

Mr. Morello stated the Borough investigated the use and need for a staffed crosswalk at Atlantic and Laurel and subsequently determined it can be eliminated. Mr. Morello stated the study included surveys to parents. Mr. Morello stated the Police Department also conducted a gap analysis and determined the intersection's design is among the safest in the Borough.

ENGINEER REPORT:

Mr. Reilly stated the written report was submitted to Council. Councilman Gilligan asked the timeline for the ADA improvements. Mr. Keenan described the schedule and stated the Senior Center is closed for renovations and the library would close during the door installation. Mr. Reilly stated the ADA project came in under budget so they are looking at other improvements that the CDBG funds can be used for.

Councilman Gilligan – Councilman Gilligan thanked Councilwoman Hall for her work on the parade and he enjoyed participating. Councilman Gilligan stated he was impressed with the response to the Webster Ave. fire and thanked all the fire companies who responded and worked very well together.

Councilman Tolomeo – Councilman Tolomeo stated enjoyed the parade too.

Mayor Keenan – Mayor Keenan thanked Councilwoman Hall and Council for their support and participation in the July 4th parade.

GOOD AND WELFARE:

John Gentless – 110 Union Avenue – Mr. Gentless asked about the sale of the Quaker Store, Bradlees, Central and Kirkwood resurfacing project and the Laurel Road Redevelopment. Mr. Keenan stated there are many items stored at the Quaker Store that do not have any historic value and the Borough would need to find a place to store these items while it is determined what to do with them. Mr. Keenan stated the new owner of Bradlees is doing roof repairs. Mr. Keenan stated the resurfacing would not include sidewalks but could include ADA compliance improvements at intersections. Mr. Keenan stated the redevelopment study would allow the Borough to offer a long-term tax abatement but does not allow for condemnation.
