### **PUBLIC PORTION FOR AGENDA ITEMS ONLY:**

Councilman Gilligan motioned to open the public portion on agenda items only. Councilwoman Lomanno seconded the motion, which passed with all members present voting in favor in a voice vote.

John Gentless, 110 Union Avenue – Mr. Gentless asked why Res. 137 was not included in the meeting packet. Mr. Keenan stated it wasn't ready. Mr. Gentless asked why Res. 146 did not mention both discussion items listed on the agenda. Mr. Bray stated both items were listed in the resolution.

Councilman Gandy motioned to close the public portion for agenda items. Councilwoman Lomanno seconded the motion, which passed with all members present voting in favor in a voice vote.

<u>POLICE/OEM REPORT</u>: Administrator/Department Head Morello provided the following report of the Stratford Borough Police Department Activities for September 2023.

- SEPT. 2 Police responded to Stratford Swim Club for the report of a car break in. Police suspect this was an act of an organized criminal group that targeted swim clubs in South Jersey this weekend.
- SEPT. 3 A masked man entered the Wells Fargo Bank vestibule where he kicked several holes into the drywall. A suspect has not been identified.
- SEPT. 5 & 9 Police responded to Jefferson Hospital on both dates for reports of staff being assaulted by psychologic patients. Police charged a 40-year-old Lindenwold woman and a 40-year-old Pine Hill man with assault on the medical staff.
- SEPT. 7 Police investigated the theft of \$840,000 for a Borough resident by his now ex-girlfriend. The suspect tried to withdraw the victim's money, which he legally won via online sport betting, from his bank account. Police were able to freeze the account before the transfer was completed.

- SEPT. 11 During the overnight, 6 unlocked vehicles were entered in the Estates section by unknown suspects looking for the keys, finding a set for a Ford Escape which was then taken from the home. Police recovered the stolen vehicle on Sept. 29 in Broomall Pa. The suspect had installed window tint and used the vehicle to steal packages in Delaware County, Pa.
- SEPT. 12 Police responded to Bishop Court Apartments for the theft of a vehicle's entire exhaust system from the manifold to the tailpipe.
- SEPT. 12 Police responded to a home for a wellness check and found a 75-year-old man deceased from natural causes.
- SEPT. 14 Police responded to Saratoga Road for the report of an unconscious 52-year-old male. Police attempted CPR but the man, who had a history of health issues, had died of natural causes.
- SEPT. 15 Police observed a known drug dealer leaving a home on Hillside Road and departing in an Uber. Police found there was an outstanding warrant for the suspect, stopped the vehicle near Yellin School and the 36-year-old Voorhees mas was found in possession of 30 bags of heroin with intent to distribute. The suspect was sent to the county jail on the outstanding warrant from a prior drug distribution charge.
- SEPT. 18 A driver lost control of their vehicle which left the roadway and became airborne before crashing into five vehicles at Echelon Ford. The driver was cited for reckless driving.
- SEPT. 15 Police observes an elderly woman in her vehicle on Stratford Avenue. Approximately 30 minutes later, Police observed the woman again and performed a wellness check, discovering that she had passed out in the hot vehicle. The police officer is credited with likely saving her life.
- SEPT. 20 Police responded to assist Somerdale Police for a disturbance at the Little Spot Bar when Officer Brunnett was assaulted. The officer suffered bruising to his face.
- SEPT. 28 Police responded to Columbia Avenue and the White Horse Pike for the report of a deranged female who climbed to the top of a ladder set up by Comcast which was performing work in the area. Police were able to convince the woman to climb down and family member stated they would take her for a psychological evaluation.
- SEPT. 28 Police responded to Jefferson Hospital for a bomb threat. Police determine the threat was made by a 35-year-old Camden man being guarded by Gloucester Township Police who had arrested and charged him with assault of a NJ Transit bus driver. Police charged him with making terroristic threats and false public alarm.
