#### PUBLIC PORTION FOR AGENDA ITEMS ONLY:

Councilwoman Lomanno motioned to open the public portion on agenda items only. Councilman Gilligan seconded the motion, which passed with all members present voting in favor in a voice vote.

John Gentless, 110 Union Avenue – Mr. Gentless asked if there was any update on the Berlin Road sewer pump station upgrades. Mr. Reilly stated they are coordinating schedules with the vendor and work is anticipated to begin soon.

Councilman Gandy motioned to close the public portion for agenda items. Councilwoman Lomanno seconded the motion, which passed with all members present voting in favor in a voice vote.

**POLICE/OEM REPORT:** Administrator/Department Head Morello provided the following report of the Stratford Borough Police Department Activities for August 2023.

Aug. 1 – Police responded to Next Gen Daycare on Arlington Avenue for a report of a two-year-old who was dropped off by Division of Child Protection caseworker but not registered to attend. Police were able to identify the child's proper daycare facility, Bundle of Joy also on Arlington Ave and the child's grandmother, and transported them to the proper location.

Aug. 9 – Police responded to a home on Cooper Ave. for a neighbor dispute that began with comments on Facebook and escalated into an in-person confrontation. Police defused the situation between the adults.

Aug. 10 – Police responded to Ryan Homes worksite on Berlin Road for the report of a stolen work van. The male suspect was identified on surveillance video and he was arrested at the Somerdale Square Methadone Clinic the following day. The 35-year-old Berlin man was charged with auto theft and released.

Aug. 11 – Police responded to the area of the Stratford firehouse for the report of a deranged man whole stole property from Stratford Tire. The suspect was a released crisis patient who allegedly stole a knife and loose

change from a vehicle. The 40-year-old suspect waived the knife in the air before dropping it. The suspect was charged with burglary and theft.

Aug. 12 – Various Borough employees and officials responded to the Laurel Mills site and nearby streets for a large volume of muddy water draining from the site onto nearby streets. NJ DEP, and Camden County and cited the property owners. Stratford fire department and DPW performed cleanup work.

Aug. 16 – Police responded to a home on West Harvard for a road rage incident. The 19-year-old suspect confronted a 45-year-old Swarthmore Avenue resident after passing their vehicle which the suspect felt was moving too slow. The suspect challenged the other driver to a fight and punched and kicked her vehicle when they refused to engage. The suspect was charged with criminal mischief and disorderly conduct.

Aug. 17 – Fire and police responded to Sleepy Hollow Road for an electrical fire. A contractor on location extinguished the fire.

Aug. 18 – A 30-year-old Lindenwold man was charged with drunken driving and Assault on Police after he pushed and punched Lt. Beasley in police headquarters.

Aug. 24 – Police responded to Penna Ave. after the alleged drunk drive crashed into his neighbor's parked car and tried to limp away. The suspect was charged with driving under the influence, open container and refusing breath test.

Officer Collins pursued the suspect and caught up to him at the Somerdale Methadone Clinic where they tried to run away. The 30-year-old Glendora man was arrested. Police also determine the suspect had suffered an overdoes on New Road in 2023 and an employee at Harry's Auto had called 911 and saved his life. Aug. 30 – A 40-year-old homeless male released from Jefferson crisis was charged with punching and grabbing Ptl. Deitz.

The Police Department is currently experiencing a staffing shortage due to an officer on leave due to a nonwork-related surgery and Officer Rebecca deciding to take an early retirement.

The Department of Public Works Supervisor and staff did a great job preparing the town for the start of school. DPW painted yellow curbs near stop signs and crosswalks on Winding Way and near Parkview Road and Hillcrest to deter parking in unsafe or illegal locations.

Mr. Reilly stated the written report was submitted to Council. Mr. Reilly state the FY 2023 CDBG repaving project bids were received and a recommendation is made for award on Tuesday subject to the solicitor's review. Mr. Reilly stated the FY 2022 CDBG funded ADA improvements are underway. NJDOT funded repaving project, Central Kirkwood Phase II is out for bids which will be opened on September 22.
