**A RESOLUTION OF THE BOROUGH OF STRATFORD REQUESTING THE NEW JERSEY DEPARTMENT OF TRANSPORTATION TO GRANT AN EXTENSION OF TIME TO JANUARY 21, 2024, FOR THE AWARD OF THE LA-2022 MA STRATFORD BOROUGH RECONSTRUCTION OF CENTRAL AVENUE & KIRKWOOD AVENUE – PHASE 2 PROJECT IN THE BOROUGH OF STRATFORD, CAMDEN COUNTY, NEW JERSEY**

**WHEREAS**, the Borough of Stratford previously applied for and received funding in the amount of \$240,000.00 from the New Jersey Department of Transportation Municipal Aid Fiscal Year 2022 Program for the LA-2022 MA Stratford Borough Reconstruction of Central Avenue & Kirkwood Avenue – Phase 2 Project,

**WHEREAS**, additional time is necessary to allow the project to be advertised and awarded with NJDOT concurrence prior to the October 21, 2023 deadline;

**WHEREAS**, an extension for the award of the construction contract until January 21, 2024 is being requested,

**NOW, THEREFORE, BE IT RESOLVED** that Council of Stratford is authorized to request an extension from the NJDOT for the award of a construction contract for the LA-2022 MA Stratford Borough Reconstruction of Central Avenue & Kirkwood Avenue – Phase 2 until January 21, 2024.
