Any member of the public who wishes to submit a public comment for a Joint Land Use Board meeting will be provided the ability to do so during a specific portion of the meeting; and

The comments/questions must include the individual's name and address and will be read into the record; and

WHEREAS, consistent with N.J.A.C. 5:39-1, this annual notice is to be posted on the Borough's website and on the door of the main public entrance to the building where the Joint Land Use Board's regular public meetings are held, along with the door for any designated and clearly delineated handicap-accessible entrance; and
