

**BOROUGH OF STRATFORD JOINT LAND USE BOARD
RESOLUTION # 2022.10**

WHEREAS, N.J.S.A. 40A:12-6 authorizes the governing body of any municipality, by Resolution, to have its Joint Land Use Board undertake a preliminary investigation to determine Whether any area of the municipality is a redevelopment area meeting the criteria set forth in N.J.S.A. 40A:12A-5; and

WHEREAS, pursuant to Resolution No. 2022:045 adopted by the Borough of Stratford on February 8, 2022 (attached as Exhibit "A"), the Mayor and Council authorized and directed the Borough of Stratford Joint Land Use Board to undertake a preliminary investigation to determine whether the proposed "Study Area," which includes Block 116, Lots 14 and 14.04 qualifies as an Area in Need of Condemnation Redevelopment pursuant to the local Redevelopment and Housing Law (N.J.S.A. 40A:12A-1 *et seq.*); and

WHEREAS, the Borough directed the Land Use Board to undertake that preliminary Investigation utilizing Steven Bach, PE, RA, PP, CME and Candace Kanaplue, PP, AICP, of Bach Associates, PC, to prepare that preliminary investigation to determine whether the Proposed Study Area qualifies as an Area in Need of Condemnation Redevelopment pursuant to N.J.S.A. 40A:12A-5; and

WHEREAS, the Borough of Stratford Joint Land Use Board conducted a public meeting on February 24, 2022 and decided to follow the recommendations of Borough Council that it direct the undertaking of the aforesaid preliminary investigation with the professionals recommended; and

NOW, THEREFORE, with the provisions of the WHEREAS clauses set forth above being incorporated herein by reference and made part hereof, BE IT RESOLVED that the Borough of Stratford Joint Land Use Board does hereby authorize Steven Bach, PE, RA, PP, CME and Candace Kanaplue, PP, AICP, of Bach Associates, PC, to conduct a preliminary investigation in order to recommend to the Borough Council whether that certain area listed in Council Resolution 2022:045 comprising of the Study Area is an Area in Need of Condemnation Redevelopment in accordance with the criteria set forth in N.J.S.A. 40A:12A-5, with the Joint Land Use Board eventually providing a written report to the Mayor and Borough Council setting forth its findings resulting from such preliminary investigation and shall recommend to the Mayor and Borough Council whether said properties are an "Area in Need of Condemnation Redevelopment" under the meaning and intent of the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, *et seq.*, in the form of a Resolution with supporting documents.


The foregoing action was taken and memorialized by the Joint Land Use Board on February 24, 2022 with the vote on the motion being as follows:
