

RESOLUTION # 01-2026

**BOROUGH OF STRATFORD, COUNTY OF CAMDEN, NEW JERSEY AUTHORIZING THE
APPOINTMENT OF BOROUGH SOLICITOR**

WHEREAS, the Borough of Stratford has determined it necessary to solicit proposals of qualifications for professional services as Borough Solicitor under a "Fair and Open Process" pursuant to the provisions of N.J.S.A. 19:44-20.4 et seq.; and

WHEREAS, the Borough of Stratford has determined and certified that the value of the services to be rendered will exceed \$17,500.00; and

WHEREAS, the anticipated term of said contract is for a period of one year and shall run from January 1, 2026 through December 31, 2026; and

WHEREAS, the Borough of Stratford has provided the necessary Public Notice for the solicitation of qualifications for professional services under the Fair and Open Process for a minimum period of ten (10) days; and

WHEREAS, the sealed qualifications, due on December 16, 2025, were submitted to the Borough Clerk of the Borough of Stratford, 307 Union Avenue, Stratford, New Jersey; and

WHEREAS, Jeffrey Brennan, Esquire of the firm of Baron and Brennan, PA submitted a proposal for Professional Services as Borough Solicitor.

NOW THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the Mayor and Borough Council of the Borough of Stratford that the Mayor and Borough Clerk are hereby authorized to enter into a contract with Stuart Platt of the firm The Platt Law Group, P.C. for the position of Borough Solicitor in the Borough of Stratford for the calendar year of 2026 pursuant to the "Fair and Open Process" which has been implemented under the "New Jersey Local Unit Pay-to Play" Law under P.L. 2004, Chapter 19 (as amended by P.L. 2005, c.51) N.J.S.A. 19:44A-20.4 et seq.

BE IT FURTHER RESOLVED that the Chief Financial Officer of the Borough has certified the availability of funds in the amount of \$85,000.00 for Borough Solicitor in accounts 6-01-20-155-000-200 which is based on a reasonable estimate of the goods and services required over the contract terms, and the local unit is not obligated to spend that amount.

BE IT FURTHER RESOLVED The Mayor, Borough Clerk are hereby authorized to execute the Borough Solicitor's Agreement for the year 2026.
