WHEREAS, John Paul II School has applied to the Borough of Stratford an application for a Special Event License; and

WHEREAS, the Special Event License will be for its Family Fun Festival carnival to be held on Thursday May 21, 2026 through Saturday May 23, 2026; and

WHEREAS, the various municipal departments have reviewed the application prior to presenting to the Governing Body; and

WHEREAS, the following conditions are being made of the applications which all must be satisfied in compliance with the Borough of Stratford Ordinance 2009:28:

Permissible hours of operation:

Thursday	May 21, 2026 during the hours of 6 o'clock p.m. through 9 o'clock p.m.
Friday	May 22, 2026 during the hours of 6 o'clock p.m. through 9 o'clock p.m.
Saturday	May 23, 2026 during the hours of 6 o'clock p.m. through 9 o'clock p.m.

WHEREAS, this approval is for the Special Event License only and does not include nor constitute approval of any carnival games licenses, which are issued separately by the Municipal Clerk in accordance with the New Jersey Legalized Games of Chance Control Commission (LGCCC) regulations.

NOW, THEREFORE, BE IT RESOLVED, by Mayor and Council to approve the Special Event License with the above conditions for the John Paul II Family Fun Festival Carnival.
