

RESOLUTION # 68-2026

**BOROUGH OF STRATFORD, COUNTY OF CAMDEN
AUTHORIZING THE DISSOLUTION OF THE PRIOR SHARED SERVICES
AGREEMENT WITH THE BOROUGH OF HADDON HEIGHTS AND THE
EXECUTION OF A NEW SHARED SERVICES AGREEMENT FOR ELECTRICAL
SUB-CODE OFFICIAL/INSPECTOR AND CONSTRUCTION OFFICIAL SERVICES**

WHEREAS, the Borough of Stratford (“Stratford”) and the Borough of Haddon Heights (“Haddon Heights”) previously entered into a Shared Services Agreement dated November 18, 2024, for the provision of Electrical Sub-Code Official/Inspector services for the term January 1, 2025 through December 31, 2028 (“Prior Agreement”); and

WHEREAS, the New Jersey Department of Community Affairs, Office of Regulatory Affairs, has advised that N.J.A.C. 5:23-4.6 does not permit modification of an existing shared services agreement to add a new subcode, and that a new four-year agreement is required if the parties wish to include additional services; and

WHEREAS, the parties desire to dissolve the Prior Agreement and enter into a new Shared Services Agreement (“Agreement”) pursuant to the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq., for the provision of both Electrical Sub-Code Official/Inspector services and Construction Official services for the term January 1, 2026 through December 31, 2029; and

WHEREAS, Stratford employs a qualified Construction Official and a qualified Electrical Sub-Code Official/Inspector and is able and willing to provide both services to Haddon Heights; and

WHEREAS, the Governing Body of Stratford finds it to be in the best interest of the Borough to dissolve the Prior Agreement and authorize the execution of the new Agreement;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Stratford, County of Camden, State of New Jersey, that:

1. The Prior Shared Services Agreement with the Borough of Haddon Heights dated November 18, 2024, for Electrical Sub-Code Official/Inspector services, is hereby dissolved and terminated, effective upon the execution of the new Agreement.
2. The new Shared Services Agreement between the Borough of Stratford and the Borough of Haddon Heights for the provision of Electrical Sub-Code Official/Inspector and Construction Official services, for the term January 1, 2026 through December 31, 2029, is hereby approved.
3. The Mayor and Borough Administrator are hereby authorized and directed to execute the new Shared Services Agreement on behalf of the Borough of Stratford.
4. A certified copy of this Resolution, together with the executed Agreement, shall be forwarded to the New Jersey Department of Community Affairs as required by N.J.A.C. 5:23-4.6(b)(1).
5. A certified copy of this Resolution shall be forwarded to the Borough of Haddon Heights for its records.
